- 2,690 hazardous materials crashes

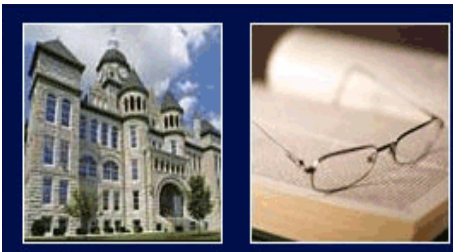

Pictures and measurements need to be made at the scene. Most importantly, the victim needs proper medical care to treat and document injuries.

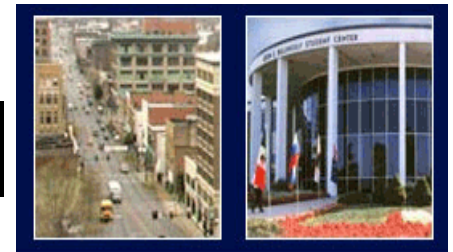
